WHILE ON PATROL IN THE 4400 BLK OF N. I35, SOUTHBOUND, I OBSERVED A WHITE CHEVEROLET BLAZER TRAVELING NEXT TO ME ON THE INTERSTATE. THE REAR BUMPER OF THE BLAZER WAS MISSING AND I DID NOT OBSERVE A LICENSE PLATE.
